THE CIRCLE:

Represents Ohana and unity among its members. (Ephesians 4)

THE WAVE:

Represents the surge of moving forward in the mission of Ohana. (Romans 15)

THE COLOR:

Represents the Holy Spirit of God and His guidance. (John 14 & 16)

OUR CHURCH PIPELINE...

LEADERS 1: KAHU (ELDERS)

Other terms: Overseer or Pastor/Shepherd
Qualifications: 1 Tim 3:1-7, Titus 1:5-9
This office is for the role of men alone

The elder's responsibility is to watch over the congregation and meet their spiritual needs. This includes teaching, training/equipping, making decisions and providing discipline for church members.

LEADERS 2: MANA'0 (DEACONS)

Other terms: Minister or Servant
Qualifications: Acts 6:1-6, 1 Tim 3:8-13

This office is for the role of men and women (Romans 16:1-2, Phoebe)

The deacon's responsibility is to minister to the physical needs of the congregation, freeing up the elders to concentrate on their spiritual needs.

MEMBERS: OHANA (MEMBERS)

Other terms: Church membership

Qualifications: Eph 2:8, Acts 2, Romans 6:3-4, Matt 28:19-20

This office is for the role of men, women, and children (Acts 2:47)

Church membership is a way of officially identifying oneself with a local body of believers. Church membership is a statement that a Christian is in agreement with that local church and is willing to be identified as a representative of it.



HOW TO BECOME A

BECOMING A MEMBER OF OHANA CHURCH

The membership of the church shall consist of persons who profess their faith in Jesus Christ as their Savior and Lord, having given public testimony to their Christian faith through believer's baptism by immersion as set forth in the New Testament. All candidates will be required to complete the membership process, affirm the church covenant by signature, affirm the church's core beliefs, and be in sympathy with the 2000 Baptist Faith and Message statement.

TERMINATION OF MEMBERSHIP AT OHANA CHURCH

Membership shall be terminated in the following ways: (1) proof of membership in another church, (2) exclusion of the member by action of this church, (3) death of the member, or (4) as a result of a non-disciplinary meeting with an elder. A member who is inactive in the church for one year may be considered for termination of membership.

DISCIPLINE AND RESTORATION OF MEMBERS AT OHANA CHURCH

Members of the church are expected to conduct their lives in accordance with biblical standards of holiness as they grow to become more like Christ. When a member knowingly, blatantly, and publicly ignores the direct commands and prohibitions of Scripture, principles of discipline and restoration will be applied.

These principles are found in passages such as Matthew 7:1-5, 18:15-17; 1 Corinthians 5:1-13; Galatians 6:1-2; 2 Thessalonians 3:6-15. The elders, who will determine whether or not a matter should be brought before the covenant membership for action, will handle corrective discipline.
